1. This contract applies to the above-described combination of boat and boat owner only. If any of the above information about the owner or boat has changed, please notify Whitehall Landing. If ownership changes or if customer vacates the slip for any reason, all slip payments shall be forfeited and this contract is null and void.
2. Rented slip will be used at the sole risk of the boat owners and their guests. Whitehall Landing is not responsible for any damage or theft of any kind to boat or contents.
3. Boat owner agrees to provide insurance for any fire, theft, loss or damage to his property, or that of others.
4. Boat owner agrees not to hire work done by a third party while boat is at Whitehall Landing without obtaining approval from the marina office.
5. No char-cooking or open flames allowed on the docks.
6. No swimming from the docks or from boat while berthed at the dock.
7. Dinghies and jet skis may not extend outside the perimeter of the slip.
8. Pets must be under full control of their owner at all times.
9. All fish cleaning must be done at the fish-cleaning station. All remains must be PLASTIC BAGGED, TIE-WRAPPED and placed in the dumpster.
10. Whitehall Landing does not warrant the condition of its driveways, walks, ramps, or docks and is not responsible for injuries to persons or property occurring thereon.
11. There will be no parking of motor homes in the parking area of the marina without obtaining permission from the marina office.
12. Any alterations made to slips must have marina's approval.
13. This contract is binding upon heirs and successors to the parties hereto.
14. Accounts must be current before boat can occupy the slip.
15. This MARINA shall be entitled to a possessory lien on said boat and/or equipment for any and all monies owed by the Boat Owner to this MARINA for storage charges, work performed, services rendered and materials furnished to the OWNER, his boat or the boat's equipment. MARINA may refuse to permit any stored items to be removed from the MARINA premises until all of the items and conditions of this Agreement have been met. Such possessory lien may be enforced in accordance with Public Act No. 362 of 1998.
16. Deposit and payments made on your slip are non-refundable and cannot be applied toward any other balance.
17. Boat owner agrees to comply with all rules, regulations and policies.
